Subject: Offer letter of appointment for the post of **Research Assistant** in extramural funded project titled "**Improving Survival in Childhood Acute Lymphoblastic in India (ISCALL): ICiCLE Implementation Study**" at AIIMS Rishikesh.

Dear Mr. Rahul Negi

You are offered temporary appointment for the post of Project Technical Support-III in extramural funded project titled "Improving Survival in Childhood Acute Lymphoblastic in India (ISCALL): ICiCLE Implementation Study" at AIIMS Rishikesh, with following terms and conditions:

- 1. Appointment is purely on temporary basis for period of twelve months.** The work of the appointee will be reviewed after three months and future extension will be given on the basis of performance.
- 2. Consolidated pay will be Rs 28,000/- +HRA 9% (Rs 2520/-) (Rs 30,520)/- per month.** Necessary reduction will be applied as per government rule.
- 3. Appointee shall perform duties assigned to him/her.** Competent authority reserves right to assign any duty equitable to post of appointee as and when required. No extra/additional allowance will be admissible in case of such assignment.
- 4. Appointee will not be granted any claim or right for regular appointment to any post at AIIMS, Rishikesh on the basis of his/ her current tenure of temporary appointment in future.** This is purely a temporary engagement for extramural project of AIIMS Rishikesh. It is not an appointment by AIIMS Rishikesh.
- 5. Appointment shall not be entitled to any benefit like pension, medical treatment, seniority, promotion, allowance etc. or any other benefits available to regular employee of AIIMS, Rishikesh.**
- 6. Appointee shall be whole time temporary employee and shall not be allowed to undertake other assignments, paid or otherwise and shall not engage himself/ herself in private business/Medical practice of any kind during period of contract.**

7. Other conditions of appointment will be governed by relevant rules and orders issued from time to time by the ICMR and administration of AIIMS, Rishikesh.
8. Appointee shall have to compulsorily reside locally after joining due to nature of work.
9. If appointee joins the post and leaves /resign before completion of tenure, he/ she have to give one month's prior notice or required to deposit one-month salary in lieu of this notice period or for period of which falls short of one month.
10. If performance of the appointee is not found satisfactory by the Principal Investigator (PI), appointment can be terminated at any time with one-week prior notice/compensation.
11. Offer of appointment is subject to re-verification of all original documents and submission of all pending papers, if any, which could not be submitted/ shown by candidates at time of interview. In case candidates fails to submit all requisite document in favor of his/ her eligibility for selected post at the time of joining, this offer of appointment will be treated as withdrawn/ cancelled.
12. If any declaration or information furnished by him/ her proves false or if he/ she is found to have willfully suppressed any material, information or any kind of misconduct, he/ she will be liable for removal from service and such other action at his/her own risk & cost.
