
Dear Ms. Prachi,

This has reference to your application & subsequent interview and assessment. We are pleased to inform you that your appointment has been approved for the post of **Medical Social Worker – Junior Research Fellow** specifically for ICMR project **“Hospital Based Cancer Registries in India”** on contractual basis with effect from **09.01.2025** for a period of **one year** on the following terms and conditions.

- (i) **Salary:-** You will be paid a consolidated salary of ₹. 32,000/- (**Rupees thirty two thousand only**) per month.
- (ii) You will be required to work as Medical Social Worker – Junior Research Fellow and shall most diligently and faithfully carry out all the assignments assigned to you by the Chief Functionary of the Project from time to time.
- (iii) Your appointment as Medical Social Worker – Junior Research Fellow is purely temporary and is only for this particular project sanctioned to under signed by ICMR. The duration of appointment will be depending on your performance and the funds available for the project. In case of termination of the project prior to completion of your tenure, your appointment will also come to an end and no compensation shall be paid in such conditions. Furthermore, you will have no claim for regular appointment in the University on termination of the project.
- (iv) **Confidentiality** : You will not divulge or disclose the information or the affair or transaction which may come to your knowledge during the course of your assignment with the project. You will also not disclose any communication made to you by the authorities of the University.
- (v) **Address** :- In case of change in the address during the course of your employment, it shall be your duty to intimate the new address in writing to the authorities within three days . All communication to you made by the authorities at your last address shall be deemed to have been delivered to you.
- (vi) **Leave** :- You will be entitled for leaves as per provision of project.
- (vii) In case of your resignation from employment before completion of specified period, one month notice or salary in lieu of the notice period will be payable by you. However, on account of misconduct or on disciplinary grounds your services may be terminated without giving any notice or payment in lieu thereof.


