

The session focused on Urolithiasis, one of the most prevalent diseases in urology, known for its significant morbidity and substantial impact on healthcare expenditure. If not timely managed, urolithiasis can lead to serious complications, including renal failure. The presentation highlighted the remarkable evolution of treatment modalities for urolithiasis—from traditional open surgeries characterized by high morbidity and visible scars, to the advent of minimally invasive endourological techniques, and now, to modern scarless procedures made possible through advancements in optics, lasers, and miniaturized instruments.

The program began with an introduction by Dr. Rajeev Sarpal, Department of Urology, who set the stage for the discussion. This was followed by two detailed case presentations from the Department of General Surgery, delivered by Dr. Aastha Raina and Dr. Gaargi Tyagi, Junior Residents, highlighting the clinical course, investigations, and management outcomes. Dr. Jyoti Chauhan, Junior Resident, presented the Uro-Radiology perspective, offering radiological insights into diagnostic approaches and procedural planning. The session concluded with a summarization of the topic by Dr. Kim J. Mammen, Department of Urology, who emphasized the progressive shift from invasive surgical methods to modern, minimally invasive and non-invasive approaches in managing urolithiasis.

A dedicated discussion and Q&A session followed, lasting approximately 15 minutes, which facilitated interactive learning and knowledge exchange among faculty and postgraduate residents. The session provided a valuable platform for sharing advancements in urological management and highlighted the importance of technological innovation and multidisciplinary collaboration in improving patient outcomes.

The second CGR, organized on 03rd August 2024, was on the topic *Current Trends in Diagnostic Approach of Idiopathic Inflammatory Myopathy*, conducted by Dr. Deepak Goel, Professor and Head of the Department of Neurology. This session discussed the evolving diagnostic strategies and clinical complexities of inflammatory myopathies, with participation from 93 faculty members and students. The third CGR, held on 24th August 2024, explored *Phakomatoses: Wyburn-Mason Syndrome* by Dr. Renu Dhasmana, Professor, Department of Ophthalmology. The discussion centred on the multisystem involvement and rare presentations of Wyburn-Mason Syndrome, drawing participation from 76 members of the academic and clinical community.

Each Clinical Grand Round session was well-structured and contributed significantly to the continuous professional development of healthcare providers. The discussions not only deepened participants' understanding of diverse clinical conditions but also encouraged interdisciplinary dialogue, integrating perspectives from neonatology, neurology, ophthalmology, and other related fields. The sessions emphasized analytical reasoning, clinical decision-making, and the application of current evidence-based practices in patient management.

Throughout the series, the Clinical Case Club played an instrumental role in coordinating and executing the events efficiently. The initiative served as a valuable platform for medical educators, residents, and students to engage in academic discussions that enhance the culture of clinical excellence within the institution. By focusing on diverse and challenging case scenarios such as refractory rhythm disorders, leprosy as a diagnostic mimic, complex cardiovascular interventions, and rare neurological conditions, the program successfully promoted collaborative learning and critical evaluation of real-world medical cases.
