Sub: Transfer from HIHT University to Swami Rama Himalayan University.

Sir/Madam,

This is to bring to your kind attention that pursuant to the orders of the Hon'ble Supreme Court of India, passed on 12th November 2013 in I.A No. 67 of 2013 in Writ Petition (Civil) No. 142 of 2006 (Viplav Sharma Vs Union of India & Ors.) and also passed on 27th November 2013 in I.A No. 01 of 2013 in Writ Petition No. 81 of 2012 (HIHT University Vs Union of India & Ors.), and further in accordance with the decision of the Board of Management of HIHT University (a Deemed to be University, established under Section 3 of the UGC Act 1956) taken in its meeting held on 05.02.2014, the HIHT University has ceased to function after 31st May 2014.

Please be informed that upon the decision coming into effect in pursuant to the orders of the Hon'ble Supreme Court of India and further in accordance with the decision taken by the Governing Body of Himalayan Institute Hospital Trust (Sponsoring Society of HIHT University and Promoting Society of Swami Rama Himalayan University) (a University enacted by Uttarakhand Act No. 12 of 2013)) and Board of Governors of Swami Rama Himalayan University all the employees who were on the rolls of HIHT University till 31st May 2014 stand transferred to Swami Rama Himalayan University on and from 1st June 2014 on the same terms & conditions of their appointment under HIHT/HIHT University.

In view of the above decision, a notice dated 3rd May 2014 was circulated by the HIHT University whereby objections, if any, were called from all the employees and it has been noted that you did not have any objection with regard to your transfer from HIHT/HIHT University to Swami Rama Himalayan University.

Please note that w.e.f. from 1st June 2014 your services are on the rolls of Swami Rama Himalayan University on the same terms & conditions on which you were appointed by, HIHT/HIHT University. Please acknowledge the receipt of this letter on its attached xerox copy.


(APPOINTMENT LETTER)


